ARTICLE VII ALCOHOLIC BEVERAGE CONTROL

- 2-7.1 ILLEGAL KEEPING OF INTOXICANTS. It shall be unlawful for a person to operate or conduct or allow to be operated, a place where intoxicating liquor is illegally kept, sold or given away.
- 2-7.2 STATE LIQUOR STORE: LOCATION. No state liquor store shall be located within three hundred (300) feet of a public or private educational institution.
- 2-7.3 PERSONS UNDER LEGAL AGE. No person shall sell, give, or otherwise supply alcoholic liquor or beer to any person knowing or having reasonable cause to believe him to be under legal age, and no person or persons under legal age shall individually or jointly have alcoholic liquor or beer in his or their possession or control, except in the case of liquor or beer given or dispensed to a person under legal age within a private home and with the knowledge and consent of the parent or guardian for beverage or medicinal purposes or as administered to him by either a physician or dentist for medicinal purposes and except to the extent that a person under legal age may handle alcoholic liquor and beer during the regular course of his or her employment by a liquor control licensee or beer permittee under State laws.
- 2-7.4 PUBLIC CONSUMPTION OR INTOXICATION. It is unlawful for any person to use or consume alcoholic liquors or beer upon the public atreets or highways, or alcoholic liquors or beer in any public place, except premises covered by a liquor control license, or to possess or consume alcoholic liquors or beer on any public school property or while attending any public or private school related function, and no person shall be intoxicated nor simulate intoxication in a public place. As used in this section "school" means a school or that portion thereof which provides teaching for any grade from kindergarten through grade twelve (12).
- 2-7.5 PROHIBITED SALES AND ACTS. No person or club holding a liquor license or beer permit nor his agents or employees shall do any of the following:
- 1. Intoxicated Persons. Sell, dispense or give to any intoxicated person, or one simulating intoxication, any alcoholic liquor or beer.
- 2. Hours of Operation. Sell or dispense any alcoholic liquor or beer on the premises covered by the license or permit, or permit thereon the consumption of beer or alcoholic liquors, between the hours of two a.m. and six a.m. on any weekday and between the hours of two a.m. and noon on Sunday and ten p.m. on Sunday and six a.m. on the following Monday.
- 3. Selling of Alcoholic Beverage to Minors. Sell, give or otherwise supply any alcoholic beverage or beer to any person knowing or having reasonable cause to believe him to be under legal age, or permit any person knowing or having reasonable cause to believe him to be under legal age, to consume any alcoholic beverage or beer.

4. Commission of Prohibited Sale of Act. The conviction of any liquor control licensee or beer permittee for a violation of any of the provisions of Section 2-7.5 shall, subject to Section 1-1.7, be grounds for the suspension or revocation of the license or permit by the department or the city.
